The Common Core State Standards for English Language Arts (ELA) have been adopted by the Kentucky Board of Education as the Kentucky Core Academic Standards (KCAS). The standards in this document have not been modified in any way and are the same as those located on the Common Core State Standard Initiatives website (<http://corestandards.org/>). Occasionally, the parenthetical list of examples and descriptors were eliminated to ensure the complete standard was included within the limited space available.

## Planning and Pacing Process

---

The Planning and Pacing Process answers the question, “How do we teach all of the grade level standards in a year?” The learning target for participation in this process: I can facilitate a discussion and process for planning and pacing the KCAS.

### Materials needed for activity:

- set of grade-level KCAS cards, color-coded by strand (RL, RI, RF, W, SL, L)
  - Example: Blue-RL, Red-RI, Yellow-RF, White-W, Pink-SL, Orange-L
- Template to guide process and report/map grouped standards

### Steps to follow:

1. Professional Learning/Training in relation to the benefits of integrating strands into instructional units
2. Teachers work in grade level groups for K – 8; 9-10 and 11-12 work together in groups. Three to four teachers per group is preferred.
3. To begin, place cards on table top in rows by strand.

4. As a collaborative group, think about which standards most *naturally* fit together into an instructional unit and pull those KCAS card(s). Record this set of standards on the Unit Planning Template that is included; label the unit with notes from the group, suggested title, etc. When this collection of standards has been recorded, flag or mark each standard card that has been used, then return the card to its place on the table.

5. Continue this process until ALL cards have been used *at least* once; remember to keep careful records of each instructional unit. In completing this process, keep in mind the cyclical nature of ELA instruction. Many standards will be repeated/reviewed throughout the year; however, only those standards that will be the focus of instruction/mastery should be included as “instructional unit” standards.
6. When your collaborative group has come to consensus about the groupings of standards into instructional units and you are satisfied with the instructional coverage of the KCAS, review the units you have included on the record-keeping template. Consider the order in which the units would most logically be taught; organize/number the new instructional units in this order.
7. Then using the template provided, KCAS Unit Organizer, discuss with your collaborative group and provide:
  - a. a unifying description and/or unit title,
  - b. the standards that would be included in this unit, and
  - c. the collaborative group’s best estimate of the number of instructional days needed to thoroughly teach the unit.
